Nevada Housing Coalition Receives \$20,000 Grant from U.S. Bank Foundation

LAS VEGAS, NV (2026) – The Nevada Housing Coalition (NHC), a nonprofit organization that brings together diverse stakeholders to address Nevada's affordable housing issues, today announced it has received a \$20,000 grant from the U.S. Bank Foundation. The annual Nevada Housing Conference, monthly virtual Lunch & Learns, and the ElevateNV Affordable Housing statewide capacity-building program are some of the key initiatives promoted by NHC, as a member-based organization.

“Safe, stable housing gives families a strong starting point and helps communities thrive,” said Arturo Pérez, community affairs manager at U.S. Bank. “Working with the Nevada Housing Coalition allows us to help more people access affordable housing and work toward long-term security.”
